While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. Convergence Long/Short Equity ETF was rated against the following numbers of US Fund Long-Short Equity funds as of 04/30/2025 over the following time periods: 5 stars - 84 funds in the last three years, 4 stars - 79 funds in the last five years, and 5 stars - 49 funds in the last ten years. The Morningstar Medalist Rating™ is the summary expression of Morningstar's forward-looking analysis of investment strategies as offered via specific vehicles using a rating scale of Gold, Silver, Bronze, Neutral, and Negative.
